Local policy is that all new smear takers should attend an approved course such as this. This course is also monitored by the SW Quality Assurance Reference Centre (Public Health England)

POLICY ON COURSE BOOKINGS AND CANCELLATIONS

- 1. No place can be confirmed on a course without receipt of the appropriate course fee.**

5. A cancellation fee of £25 plus VAT will be charged for any cancellation made at less than 9 days prior to the course.
